As required by the CARES Act and in compliance with guidance from the U.S. Department of Education, Fresno Pacific University (FPU) reports its use of the Emergency Financial Aid Grants to students.

- 1. On April 9, 2020 FPU signed and returned to the U.S. Department of Education its Certification and Agreement that the university has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students. On April 20, 2020 FPU was awarded \$2,060,779 from the U.S. Department of Education for Emergency Financial Aid Grants to Students. On Jan 17, 2021 FPU was awarded an additional \$2,060,779 and on May 19, 2021 an additional \$6,250,195.
- 2. On April 23, 2020 FPU signed and returned to the U.S. Department of Education its Certification and Agreement to receive the Institutional Portion of the Higher Education Emergency Relief Fund. On May 6, 2020 FPU was awarded \$2,060,778 from the U.S. Department of Education to cover any costs associated with significant changes to the delivery of instruction due to the coronavirus so long as such costs do not include payment to contractors for the provision of pre- enrollment recruitment activities, including marketing and advertising; endowments; or capital outlays associated with facilities related to athletics, sectarian instruction, or religious worship (Institutional Portion). On Jan 17, 2021 FPU was awarded an additional \$5,007,396 and on May 19, 2021 an additional \$5,917,109.
- 3. On May 1, 2020 FPU, because of its status as a Minority Serving Institution, signed and returned to the U.S. Department of Education its Certification and Agreement to receive MSI funds under the Higher Education Emergency Relief Fund. On June 4, 2020 FPU was awarded \$293,109 from the U.S. Department of Education to address needs directly related to the coronavirus (MSI Funds). On Oct 24, 2021 FPU was awarded an additional \$2,439 and on Mar 3, 2021 an additional \$449,469.
- 4. As of June 30, 2021 FPU has expended \$58,535 of the MSI funds: \$35,330 for student grants, \$7,405 for computer equipment, and \$15,800 for instructional design of online courses.
- 5. FPU is currently considering how best to utilize remaining MSI funds.
- 6. All requests for MSI Funds are submitted to the CFO, who reviews them with the President's Cabinet before approving them. Expenses for the Student Portion, Institutional Portion, and MSI funds are tracked separately by the university Business Office.
